**AMENDMENT NUMBER 1/FIRST EXTENSION TO THE AGREEMENT
FOR FIRE RESCUE CLOTHING & T-SHIRTS**

THIS AGREEMENT entered into this 28th day of May, 2014 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **BAKER'S SPORTS** located at 3600 Beachwood Court, Jacksonville, FL 32224; (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an agreement on February 20, 2013 for the purchase of Fire Rescue Clothing & T-Shirts; and

WHEREAS, the parties desire to amend and extend said Agreement.

1. The performance period is hereby extended for an additional period beginning October 1, 2014 and ending September 30, 2015.
