**GRANT OF EASEMENT AND  
PERPETUAL MAINTENANCE AGREEMENT**

THIS EASEMENT AGREEMENT dated this <sup>22<sup>nd</sup></sup>~~30<sup>th</sup>~~ day of ~~July~~ <sup>September</sup> <sup>BW</sup>, 2014, by  
and between JOHN PHILLIP AND LINDA G. REEVES, hereinafter referred to as  
"Grantors", and the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY,  
FLORIDA, a political subdivision of the State of Florida, hereinafter referred to  
as the "County".

**WHEREAS** Grantors are the owners of certain lands identified in Nassau  
County Official Record Book 1081, Page 438 as Parcel Number 03-2N-23-0000-  
0008-0010 (the "Subject Property"); and

**WHEREAS** Grantors desire to convey to the County a Temporary  
Construction Easement for the construction of proposed improvements within  
their property, which Temporary Construction Easement Area is more particularly  
described in Exhibit "A" attached hereto; and

**WHEREAS** Grantors desire to convey to the County a Permanent Drainage  
Easement for the perpetual maintenance of the proposed improvement, which  
Permanent Drainage Easement Area is more particularly described in Exhibit "B"  
attached hereto; and

**WHEREAS** the County shall construct the aforementioned drainage improvements that will include double 54-inch cross drains sand cement end walls, and associated roadway and erosion control measures within the Temporary Construction Easement in order to replace the existing culverts and endwalls; and


**WHEREAS** the County shall maintain in perpetuity the aforementioned drainage improvements with the Permanent Drainage Easement.

**FOR and IN CONSIDERATION** of the mutual covenants and agreements hereinafter contained, the parties hereto agree as follows:

1. Grantor hereby dedicates to the County for public use a non-exclusive Temporary Construction Easement as well as a non-exclusive Perpetual Drainage Easement in, over, under, upon, and through the Easement Areas fully described in Exhibits "A" and "B" attached hereto.
2. The County shall contain all proposed construction activities lying within the Temporary Construction Easement areas and maintain, in perpetuity all proposed drainage improvements lying within the Permanent Drainage Easement area. Except during construction or in emergency circumstances, the County shall enter upon the easement area during normal business hours, for maintenance purposes.
3. In the event any maintenance performed by the County, modifies, damages or disturbs the surface of the Easement Area, the County will make reasonable repairs to restore the surface area.

4. This Agreement shall run with title to the Subject Property and shall be binding on the Grantors' successors, assigns, and heirs. This Agreement shall inure to the benefit of the County, its successors and assigns.
5. This Agreement shall be recorded in the public records of Nassau County, Florida.
6. This Agreement is to be governed by the laws of Florida in all respects without reference to the laws of any other state or nation. The venue of any action taken pursuant to this Contract shall be in Nassau County, Florida.
