## AMENDMENT NUMBER 1 / FIRST EXTENSION TO THE AGREEMENT FOR MISDEMEANOR PROBATION SERVICES FOR THE FOURTH JUDICIAL CIRCUIT, IN AND FOR NASSAU COUNTY, FL

November , 2010 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, on behalf of the Chief Judge, Fourth Judicial Circuit, hereinafter referred to as "County" and the SALVATION ARMY, A Georgia corporation authorized to do business in the State of Florida as a foreign non profit corporation, hereinafter referred to as "Contractor" (collectively, the "parties").

WHEREAS, the parties entered into on December 1, 2008 a Contract for Misdemeanor Probation Services for the Fourth Judicial Circuit, in and for Nassau County, Fl ("Contract"), which by its terms will expire November 30, 2010; and

WHEREAS, the original Contract provided for an initial two (2) year term beginning December 1, 2008 and ending November 30, 2010, with an option to extend upon mutual agreement between the parties; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties desire to amend said Contract to allow for automatic extensions in one month increments.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. The Contract is hereby extended to December 31, 2010.
- 2. The Contract shall automatically thereafter extend for successive additional one (1) month increments unless until one of the undersigned parties notify the other of their desire to terminate the Contract.
- 3. Article 5 Termination shall be amended as follows: In the event that either party desires to terminate the Contract, notice shall be given not later than the 1<sup>st</sup> day of the applicable month that the party desires to terminate the Contract.

  [Example: If a party notifies the other party on January 1<sup>st</sup> of a desire to terminate, then the Contract will end on January 31<sup>th</sup>.]
- 4. All other provisions of said Contract not in conflict with this Amendment shall remain in full force and effect.
