WHEREAS, the Board of County Commissioners is desirous of successful economic development within Nassau County that will provide new jobs and broaden the tax base; and

WHEREAS, the Board and the Nassau County Economic Development Board, Inc., entered into an Agreement on May 11, 1998 to provide funding to the Nassau County Economic Development Board, Inc., in order to further economic development efforts; and

WHEREAS, it was determined to be in the best interest of Nassau County to amend the agreement entered into on May 11, 1998; and

WHEREAS, it became necessary to amend the agreement entered into on July 10, 2006, specifically Section 7 regarding funding; and

WHEREAS, Section 11 regarding the audit requirements was amended on February 23, 2009; and

WHEREAS, the parties desire to amend and extend said
agreement; and

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

- 1. This Agreement shall be effective for the period October 1, 2010 through September 30, 2011, unless terminated by either party upon thirty (30) days written notice to the other party, subject to completion of all previous and outstanding billings.
- 2. The funding for Fiscal Year 2010-2011 shall be \$112,500.00.
- 3. This Agreement shall be amended in writing from time to time by mutual consent of parties.
- 4. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 5. Time is of the essence.
