**ELEVENTH AMENDMENT TO PURCHASE, INSTALLATION AND
MAINTENANCE SERVICE CONTRACT**

**Training, Maintenance and Warranty Service for the
Nassau County E911 System**

THIS AMENDMENT made and entered into by and between the **Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Amendment for training, maintenance, warranty and support for the E911 System and associated programs and applications.

WHEREAS, the parties entered into the original contract on the 20th day of January, 2009; and

WHEREAS, the equipment installation has been completed and is operational, and the maintenance and warranty period has begun; and

WHEREAS, the contract allows for the Solacom and PlantCML Extended Warranty to be adjusted annually by the manufacturer and provided by AK Associates at cost with no additional markup; and

WHEREAS, the State of Florida E911 Board approved the Spring 2014 Rural County Grant Program Application

request, E911 Rural County Grant No. 14-4-19 in the amount of \$46,237.00 for E911 Maintenance.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. SECTION II, 2. Costs, A. AK Elite Premier Maintenance and PlantCML Extended Warranty Payment Schedule as follows:

2. SECTION III, 2. Term of Agreement: The "Initial Term" of this agreement terminates on January 19, 2014. Amendment No. 10 extended the agreement for the period beginning January 20, 2014 and ending January 19, 2015. This Agreement shall automatically renew for a one (1) year period beginning January 20, 2015 and ending January 19, 2016.

3. All other provisions of the original contract shall remain the same and in full force and effect.


