**AMENDMENT NUMBER 3/THIRD EXTENSION TO THE**  
**AGREEMENT FOR EMS ONLINE TRAINING**

THIS AMENDMENT entered into this 13th day of January, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **TARGET SAFETY.COM dba TARGET SOLUTIONS**, 10805 Rancho Bernardo Road, Suite 200, San Diego, California 92127, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated March 1, 2012; and

**WHEREAS**, the original agreement provided for an initial term beginning February 29, 2012 and ending February 28, 2013, with an option to automatically renew for another twelve (12) month period unless vendor receives written notice of cancellation; and


**WHEREAS**, the parties agreed to extend the agreement for the annual periods beginning March 1, 2013 and ending February 28, 2015; and
