S2Li anticipates that the services described herein are expected to be completed within 21 days of written Notice to Proceed contingent upon the availability of equipment.

Scope of Services

Well No. 2i Investigation at the Bryceville Landfill

County Contract Number: CM2096-WA07 S2Li Project Number: 14-578

Monitoring Well MW-2i at Nassau County's closed Bryceville Landfill has, since 1999, produced groundwater samples with analytical results for lead exceeding the Primary Drinking Water Standards Maximum Contaminant Level of 15 ug/l. Reported lead concentrations at the well have ranged from 19 ug/l to 374 ug/l. The most recent result in June 2014 was 69 ug/l. Sample turbidity has, from time to time, ranged above the Florida Department of Environmental Protection (FDEP) recommend limit of 20 NTUs. Elevated turbidity does not appear to correlate directly to exceeding lead concentrations reported.

The total depth of MW-2i was reported prior to December 2000 at 62 feet below top of casing. Beginning in December 2000, total well depth was reported to be 55.52 feet. Either total depth was mis-measured at some point, or the well has filled in with sediment or other obstruction. The original well construction completion report from September 1990 specifies total well depth at 62.85 feet below top of casing.

Nassau County (County) has asked S2L, Incorporated (S2Li) and its team of subconsultants (collectively known as the S2Li Team) to complete an investigation of monitoring well MW-2i in an attempt to determine whether lead concentrations reported in groundwater samples from the well are the result of sediment infilling or the presence of a foreign object, such as a lead weight, in the bottom of the well. Use and loss of lead weights on water level measuring devices are not uncommon.

This Work Authorization will provide engineering and hydrogeological consulting services in an attempt to determine the potential cause of lead concentrations reported in groundwater samples from the Bryceville Landfill Well No. 2i.

Scope of Services

Under the scope of services for this Work Authorization, S2Li Team will perform the following:

- Measure the apparent total depth of the well for comparison to the original as-built construction depth and determine whether the well appears to be in-filled with sediment by physically probing from the wellhead;
- Clear and visually evaluate any sediments present in the lower portion of the well using airlift equipment until the original total well depth is attained. Equipment used in the investigation will be decontaminated in accordance with the latest issue of the FDEP Standard Operating Procedures for Field Activities prior to introduction into the well;

- Redevelop the well using conventional pumping equipment until produced groundwater is clear and free of suspend particles and fluid turbidity measurements less than 20 NTUs are consistently measured;
- 5. Complete a visual survey of the interior of the well using a down-hole video camera to look for foreign objects which might have fallen into the well; and
- 6. Prepare a written letter report documenting the results of the field investigation and presenting conclusions (if possible) regarding a possible link between sediments or objects found in the well and high lead concentrations reported in groundwater samples.

Schedule

Work Authorization under the Scope of Services provided above is expected to be completed within 21 days of a written Notice-to-Proceed contingent upon the availability of equipment.

Cost Estimate

The cost estimate to conduct the Work as described in the above listed Scope of Services is \$6,499.93. A detailed breakdown with the estimated labor hours, contract labor rates, and expenses are included in the attached Exhibit 1 for the S2Li Team. Costs incurred will be invoiced on a time and material basis. The County will be notified when the overall project budget is nearing its limit.
