AMENDMENT NO. 2 / SECOND EXTENSION TO THE
AGREEMENT FOR FIRE RESCUE CLOTHING & T-SHIRTS

THIS ADDENDUM entered into this 9th day of June, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **BAKER'S SPORTS, INC.**, 3600 Beachwood Court, Jacksonville, FL 32224, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated February 20, 2013 for Fire Rescue Clothing & T-Shirts; and

WHEREAS, the original agreement provided for an initial beginning February 20, 2013 and ending September 30, 2014, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and


WHEREAS, the parties entered into a renewal period beginning October 1, 2014 and ending September 30, 2015; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 20 of the Agreement for Fire Rescue Clothing & T-Shirts dated February 20, 2014, the performance period is hereby extended for an additional one (1) year beginning October 1, 2015 and ending September 30, 2016.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
