**AMENDMENT NO. 1 / FIRST EXTENSION TO THE  
AGREEMENT FOR TANK WAGON GASOLINE & DIESEL FUEL**

THIS ADDENDUM entered into this 23rd day of July, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **LV HIERS, INC.**, 253 East Florida Avenue, P.O. Box 1229, Macclenny, FL 32063, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into a Piggyback Agreement dated November 10, 2014 utilizing the State of Florida, Department of Corrections contract for Tank Wagon Gasoline & Diesel Fuel, Contract No. 09-DC-8148; and

**WHEREAS**, the original agreement with the State of Florida, Department of Corrections provided for an initial term of five (5) years beginning May 26, 2010 and ending May 25, 2015, with an option to extend for an additional five (5) year term;


**WHEREAS**, the State of Florida, Department of Corrections entered into an extension with Vendor for the period through May 25, 2020;

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 3 of the Agreement for Tank Wagon Gasoline & Diesel Fuel dated November 10, 2014, the performance period is hereby extended for an additional five (5) years beginning May 26, 2015 and ending May 25, 2020.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
