Palmetto Products Pipe Line, LLC ("Palmetto") is proposing to construct a new pipeline that will transport gasoline, diesel, and ethanol from Belton, South Carolina, to markets in North Augusta, South Carolina, Savannah, Georgia, and Jacksonville, Florida, I have enclosed a preliminary project map for your review. You are receiving this letter because, based on a preliminary review, Palmetto has determined that you may own property that may be impacted by this project.

This project will consist of a new 360-mile pipeline with a capacity to transport up to 167,000 barrels per day. The project will also include the construction of storage tanks, pump stations, and delivery terminals.

Palmetto will be evaluating various possibilities for areas where its pipeline and other facilities might be constructed. In order to accomplish this, the first activity to be undertaken is route determination and surveys. There will be several types of surveys to be conducted, including civil, environmental, and cultural or archeological surveys. These surveys will occur intermittently and are expected to commence during the first quarter of 2015.

An agent representing Palmetto will be contacting you to discuss the project and survey activities and to address any questions or concerns you might have. Upon completion of the surveys, if it is determined that the proposed pipeline route will cross your property, then an agent will re-contact you and make a written offer for the purchase of an easement and other rights as needed.


Palmetto Pipeline Project Fact Sheet

- Kinder Morgan proposes the approximately \$1 billion Palmetto Pipeline Project, which is designed to transport gasoline, diesel and ethanol from Baton Rouge, Louisiana, Collins and Pascagoula, Mississippi, and Belton, South Carolina, to markets in North Augusta, South Carolina, Savannah, Georgia, and Jacksonville, Florida.
- Palmetto is supported by long-term commercial commitments from multiple customers. The proposed pipeline will have a design capacity of up to 167,000 barrels per day and will consist of a segment of newly constructed expansion capacity that Palmetto will lease from Plantation Pipe Line Company between Baton Rouge and Belton. A new 360-mile pipeline from Belton to Jacksonville would also be constructed as part of the project.
- Additional facilities, including product storage tanks, pump stations and delivery terminals, will be constructed as part of the Palmetto project.
- The project will generate approximately 1,200 temporary construction jobs at its peak and an estimated 28 permanent full-time positions. The estimated annual revenue to state and local taxing bodies from this project will be over \$14 million when completed.
- A number of federal and state agencies will be involved in the approval and oversight of the project, including the U.S. Army Corps of Engineers, South Carolina Department of Natural Resources, Florida Department of Environmental Protection and the Georgia Department of Natural Resources.
