AMENDMENT NUMBER 1/FIRST EXTENSION TO THE GOLD SERVICE AGREEMENT FOR NASSAU COUNTY HISTORIC COURTHOUSE

THIS AGREEMENT entered into this <u>xxxx</u> day of <u>September</u>, 2014 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and THYSSENKRUPP ELEVATOR CORPORATION located at 6942 Phillips Parkway Drive South, Jacksonville, FL 32256; (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an agreement on October 9, 2013 for monthly preventive elevator maintenance at the Historic Courthouse; and
