Additional terms or conditions whether submitted purposely or inadvertently, shall have no force or effect.
- 2. The Markup price for Nassau County shall be \$0.12000 which is the price stated on the Cost Information Sheet for the adjacent counties of Duval County and Baker County.
- 3. Notwithstanding any other provision of the piggyback contract to the contrary:
 - a. The term of this agreement shall be begin upon the date of execution by the County and end May 25, 2015. The contract may be renewed for a period of five (5) years at the County's sole discretion; during which term total purchases shall not exceed \$50,000.00 unless approved by the Nassau County Board of County Commissioners.
