WHEREAS, the parties desire to amend and extend said Agreement.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

Center dated January 23, 2009, the performance period is hereby extended for an additional one (1) year beginning October 1, 2009 and ending September 30, 2010.




