**AMENDMENT NO. 2 / SECOND EXTENSION TO THE
INDEPENDENT CONTRACTOR AGREEMENT**

THIS ADDENDUM entered into this 22nd day of June, 2010 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **C.A. ROMANO**, 76347 Veterans Way, Suite 3-027, Yulee, FL, 32097, (hereinafter referred to as "Independent Contractor").

WHEREAS, the parties entered into an Agreement dated February 11, 2009, for services for a Librarian Director for the Nassau County Law Library; and

WHEREAS, the original agreement provided for an initial term of February 11, 2009 through September 30, 2009 and provided for one year renewals upon mutual agreement of the parties; and

WHEREAS, the parties mutually agreed to renew the agreement for the period beginning October 1, 2009 and ending September 30, 2010; and

WHEREAS, the parties desire to extend said Agreement;

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 8 of the Independent Contractor Agreement dated February 11, 2009, the performance period is hereby extended for an additional one (1) year beginning October 1, 2010 and ending September 30, 2011.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
