**AMENDMENT NUMBER 1/FIRST EXTENSION TO THE  
AGREEMENT FOR MONITORING SERVICES AT CALLAHAN BRANCH  
LIBRARY**

THIS ADDENDUM entered into this 19<sup>th</sup> day of Sept., 2010 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **B.J. BARR'S PERSONAL SAFETY DEVICES dba ISLAND SECURITY**, P.O. Box 16539, Jacksonville, Florida 32245, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated September 10, 2009 for monitoring services for Callahan Branch Library; and

**WHEREAS**, the original agreement provided for an initial term beginning October 1, 2009 and ending September 30, 2010, and allowed for renewals of one year periods; and

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended, at the same cost, for an additional one (1) year beginning October 1, 2010 and ending September 30, 2011.

- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
