

**THIRD AMENDMENT TO AGREEMENT FOR FEDERAL LOBBYIST  
SERVICES**

THIS ADDENDUM entered into this 13th day of September, 2010 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **JACOBS SCHOLZ & ASSOCIATES, LLC**, 961687 Gateway Boulevard, Suite 201-I, Fernandina Beach, Florida 32034, (hereinafter referred to as "Jacobs Scholz & Associates").

**WHEREAS**, the parties entered into an Agreement dated December 10, 2008 for the provision of services of a professional nature to represent Nassau County before the United States Congress, Cabinet, the President, and federal agencies; and

**WHEREAS**, the original agreement provided for an initial term beginning December 10, 2008 and ending after a four month period; and

**WHEREAS**, the parties agreed to amend and extend the agreement for the remainder of the fiscal year ending September 30, 2009 and for a subsequent renewal for the period beginning October 1, 2009 and ending September 30, 2010; and

**WHEREAS**, the parties desire to amend and extend said Agreement.


**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


