

**SIXTH AMENDMENT TO PURCHASE, INSTALLATION AND
MAINTENANCE SERVICE CONTRACT**

**Elite Premier Purchase, Installation and Maintenance
Service**

THIS AMENDMENT made and entered into by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Sixth Amendment to Purchase, Installation And Maintenance Service Contract for Elite Premier Purchase, Installation and Maintenance.

WHEREAS, the parties entered into the original contract on the 20th day of January, 2009; and

WHEREAS, the equipment installation has been installed and is operational, and the maintenance and warranty period has begun; and

WHEREAS, Nassau County has Enhanced 911 and Phase I and Phase II wireless as defined by the State 911 Plan; and

WHEREAS, Nassau County is committed to maintaining the highest level of mapping, addressing and data accuracy in its newly installed E911 system; and

WHEREAS, our goal is to ensure that our County's E911 system has the most accurate 9-1-1 mapping, addressing and Geographic Information System (GIS) databases for daily E911 operations and ongoing data maintenance and updates; and

WHEREAS, there is a need for the InterAct CAD integration with Contact One's Quick Point Map display so that both the PlantCML 911 equipment and the InterAct CAD map effectively communicate; and

WHEREAS, InterAct CAD will utilize a single map display and create a more accurate map display which will aid call takers and dispatchers and reduce the time to locate and dispatch an emergency response to an emergency.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. Contractor shall provide an interface (API) with InterAct CAD.

2. Compensation to Contractor for the InterAct CAD Interface shall be as follows:
