**SEVENTH AMENDMENT TO PURCHASE, INSTALLATION AND  
MAINTENANCE SERVICE CONTRACT**

**Elite Premier Purchase, Installation and Maintenance  
Service**

**THIS AMENDMENT** made and entered into by and between the **Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Seventh Amendment to Purchase, Installation And Maintenance Service Contract for Elite Premier Purchase, Installation and Maintenance.

**WHEREAS**, the parties entered into the original contract on the 20<sup>th</sup> day of January, 2009; and

**WHEREAS**, the equipment installation has been installed and is operational, and the maintenance and warranty period has begun; and

**WHEREAS**, Nassau County has Enhanced 911 and Phase I and Phase II wireless as defined by the State 911 Plan; and

**WHEREAS**, Nassau County is committed to maintaining the highest level of mapping, addressing and data accuracy in its newly installed E911 system; and

WHEREAS, our goal is to ensure that our County's E911 system has the most accurate 9-1-1 mapping, addressing and Geographic Information System (GIS) databases for daily E911 operations and ongoing data maintenance and updates; and

WHEREAS, InterAct annual maintenance support is ongoing for software support of the CAD system used to dispatch and track 911 call activity from when a call is received to the time that the incident is closed; and

WHEREAS, InterAct annual support provides the County with a single point of contact for 9-1-1 related issues.

**NOW, THEREFORE,** for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. Contractor shall InterAct Annual Maintenance Support.

2. Compensation to Contractor for the InterAct Annual Maintenance Support shall be as follows:
