SECOND AMENDMENT TO VENDOR AGREEMENT WITH NASSAU OAKS
VOLUNTEER FIRE DEPARTMENT

THIS AGREEMENT made and entered into this 8th day of February, ~~2010~~²⁰¹¹ by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as the "Board", and the **STATION NUMBER 11, NASSAU OAKS VOLUNTEER FIRE DEPARTMENT**, 56300 Nassau Oaks Drive, Callahan, Florida 32011, hereinafter referred to as "Department".

WHEREAS, the Board and the Department entered into an agreement on June 9, 2008 to provide funding to the Department and establish the needs for assistance in providing Fire Suppression and First Responder services to the citizens of Nassau County; and

WHEREAS, it has become necessary to amend the agreement entered into on June 9, 2008, specifically Article 2.1 regarding funding; and

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

1. The annual appropriation shall decrease to \$47,078.00 (forty-seven thousand, seventy-eight dollars and zero cents).
2. This Agreement shall be amended in writing from time to time by mutual consent of parties.
