**AMENDMENT NUMBER 1 / FIRST EXTENSION TO THE

THIS ADDENDUM entered into this 3rd day of March, 2011 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **EVELYN JONES**, 1748 Julia Street, American Beach, FL, 32034, (hereinafter referred to as "Independent Contractor").

WHEREAS, the parties entered into an Agreement dated April 12, 2010, for Custodial Services for Bryceville Community Center; and

WHEREAS, the original agreement provided for an initial term of April 12, 2010 through April 11, 2011 and provided for one year renewals upon mutual agreement of the parties; and


WHEREAS, the parties desire to extend said Agreement.


