AMENDMENT NUMBER 1/FIRST EXTENSION TO THE SALE AND SERVICE AGREEMENT

THIS AGREEMENT entered into this ^{23rdth}~~XXXX~~ day of October, 2014 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **AIM** located at 11657 Central Parkway, Suite 401, Jacksonville, FL 32225; (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an agreement on September 20, 2013 for service on an Oce' PW 340, 2 roll, 36 inch copier, printer, color scanner for Engineering Services; and


WHEREAS, the original agreement provided for an initial twelve month term beginning upon installation with an option to renew for successive additional twelve month periods with written notice;


WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended for an additional period beginning September 20, 2014 and ending September 19, 2015.
2. Monthly Base Charge shall increase to One Hundred Dollars (\$100.00) per month, which is still an approximate twenty-six percent discount.
3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.


