

**AMENDMENT NUMBER 1/FIRST EXTENSION TO THE CONTINUING  
CONTRACT FOR MISCELLANEOUS ENGINEERING SERVICES FOR NASSAU  
AMELIA UTILITY**

THIS AGREEMENT entered into this 8th day of December, 2014 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **GAI CONSULTANTS, INC.** located at 618 E. South Street, Orlando, FL 32801; (hereinafter referred to as "Consultant").

**WHEREAS**, the parties entered into an agreement on March 21, 2012 for professional engineering services in connection with Nassau Amelia Utility; and

**WHEREAS**, the original agreement provided for an initial three year term beginning March 21, 2012 and ending March 20, 2015 with an option to renew for two additional one year periods;

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. The performance period is hereby extended for an additional period beginning March 21, 2015 and ending March 20, 2016.




