

**AMENDMENT NUMBER 4/FOURTH EXTENSION TO THE CONTRACT FOR SAISS PROJECT ESCARPMENT REMOVAL AND TILLING**

THIS AMENDMENT entered into this 16th day of March, 2016 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **EASTMAN AGGREGATE ENTERPRISES, LLC**, 3705 Bellevue Avenue, Lake Worth, Florida 33461, (hereinafter referred to as "Contractor").

**WHEREAS**, the parties entered into an Agreement dated March 22, 2012; and

**WHEREAS**, the original agreement provided for an initial term beginning March 22, 2012 and ending March 21, 2013, with an option to extend for four (4) additional one (1) year periods upon written agreement of both parties; and


**WHEREAS**, the parties agreed to extend the agreement for the period March 22, 2013 through March 21, 2014, March 22, 2014 through March 21, 2015 and March 22, 2015 through March 21, 2016; and

**WHEREAS**, the parties desire to amend and extend said Agreement for the final extension period; and


**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 2 of the Contract for SAISS Project Escarpment Removal and Tilling dated March 22, 2012, the performance period is hereby extended for an additional one (1) year beginning March 22, 2016 and ending March 21, 2017.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
