




SEVENTH AMENDMENT TO THE AGREEMENT FOR WEBSITE DEVELOPMENT SERVICES FOR NASSAU COUNTY, FLORIDA

THIS AGREEMENT made and entered into this 14th day of August, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY**, a political subdivision of the State of Florida, hereinafter referred to as the "Board", and **ICON ENTERPRISES, INC., dba CIVIC PLUS**, 317 Houston Street, Suite E, Manhattan, KS 66502, hereinafter referred to as "Consultant".

WHEREAS, the Board and the Consultant entered into an agreement on November 19, 2008 to provide website development services; and

WHEREAS, the original agreement provided for an initial term beginning November 19, 2008 and ending November 18, 2011, with an option to extend upon mutual contract between the Consultant and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties agreed to extend the agreement for the periods beginning November 19, 2011 and ending November 18, 2015; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

1. In accordance with Section 4 of the Agreement dated November 19, 2008, the performance period is hereby extended for an additional one (1) year beginning November 19, 2015 and ending November 18, 2016.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
