AMENDMENT NO. 1 / SECOND AUTOMATIC EXTENSION TO THE MAINTENANCE AGREEMENT FOR ELEVATOR MAINTENANCE AND REPAIR SERVICES

THIS ADDENDUM entered into this 17th day , 2015 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and SCHINDLER ELEVATOR CORPORATION, 9143 Philips Highway, Suite 260, Jacksonville, FL 32256, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated September 27, 2013 for elevator maintenance and repair services for the Robert M. Foster Justice Center; and

whereas, the original agreement provided for an initial term of one (1) year beginning October 1, 2013 and ending September 30, 2014, with an option for the agreement to automatically renew for successive similar unless terminated by either party upon written notice received by the other part at least ninety (90) days prior to the termination date or any renewal termination date; and

whereas, the parties allowed for a subsequent automatic renewal for the period of October 1, 2014 through September 30, 2015, which included an annual price adjustment beginning January 1, 2015; and

WHEREAS, the parties desire to amend and extend said

Agreement for an additional one year term.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with the Maintenance Agreement for Elevator Maintenance and Repair Services dated September 27, 2013, the performance period is hereby extended for an additional one (1) year beginning October 1, 2015 and ending September 30, 2016.
- 2. In consideration of the services provided, the County will pay the sum of \$567.93 per month, payable in a quarterly installment of \$1,703.79 for the period of October through December 2014. The adjusted annual rate beginning January will increase to the sum of \$586.84 per month, payable in quarterly installment of \$1,760.52 for the period of January through September 2016.
- 3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
