

**AMENDMENT NO. 1 / FIRST EXTENSION TO THE**  
**CONTRACT FOR CONCRETE CULVERT**

THIS ADDENDUM entered into this 17th day of August, 2016 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **COUNTY MATERIALS CORPORATION**, 25750 CR 561, P.O. Box 435, Astatula, Florida 34705, (hereinafter referred to as "Vendor").

**WHEREAS**, the parties entered into an Agreement dated August 25, 2014; and

**WHEREAS**, the original agreement provided for an initial term of two (2) years beginning August 13, 2014 and ending August 12, 2016, with an option to renew for one (1) additional year; and

**WHEREAS**, the parties desire to amend and extend said Agreement; and

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with the Contract for Concrete Culvert dated August 25, 2014, the performance period is hereby extended for an additional one (1)

year beginning August 13, 2016 and ending August 12, 2017.

- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
