TWELTH AMENDMENT TO PURCHASE, INSTALLATION AND MAINTENANCE SERVICE CONTRACT

Training, Maintenance and Warranty Service for the Nassau County E911 System

THIS AMENDMENT made and entered into this <u>6th</u> day of <u>October</u>, 2015 by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida, hereinafter referred to as the "County", and the Kraus Associates Inc., DBA AK Associates hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Amendment for training, maintenance, warranty and support for the E911 System and associated programs and applications.

WHEREAS, the parties entered into the original contract on the 20th day of January, 2009 for the initial five (5) year term beginning January 20, 2009 and ending January 19, 2014; and

WHEREAS, the equipment installation has been completed and is operational, and the maintenance and warranty period has begun; and

WHEREAS, the contract allows the agreement to automatically renew and continue in force on a year-to-year basis until terminated by either party; and

WHEREAS, the parties entered into subsequent renewal periods beginning January 20, 2014 through January 19, 2016; and

WHEREAS, on 9/9/14 the parties entered into a subsequent agreement to upgrade the Solacom Selective Router and install Guardian call taking equipment that replaced the Plant CML 911 equipment. The upgrade was completed and placed into service on 3/17/15; and

WHEREAS, the State of Florida E911 Board approved the Spring 2015 Rural County Grant Program Application request, E911 Rural County Grant No. 15-04-18 in the amount of \$36,460.00 for E911 Maintenance.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:
