**AMENDMENT NUMBER 6/SIXTH EXTENSION TO THE
CUSTODIAL SERVICES AGREEMENT**

THIS ADDENDUM entered into this 30th day of March, 2016 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **EVELYN JONES**, 1748 Julia Street, American Beach, FL, 32034, (hereinafter referred to as "Independent Contractor").

WHEREAS, the parties entered into an Agreement dated April 12, 2010, for Custodial Services for American Beach Community Center; and

WHEREAS, the original agreement provided for an initial term of April 12, 2010 through April 11, 2011 and provided for one year renewals upon mutual agreement of the parties; and


WHEREAS, the agreement was extended for the subsequent annual periods beginning April 12, 2011 and ending April 11, 2016; and

1. In accordance with Section 3 of the Agreement dated April 12, 2010, the performance period is hereby extended for an additional one (1) year beginning April 12, 2016 and ending April 11, 2017.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.
