AMENDMENT NUMBER 6/SIXTH EXTENSION TO THE
CUSTODIAL SERVICES AGREEMENT

THIS ADDENDUM entered into this 1st day of September, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **SHARLEENE CARTER**, 75668 Johnson Lake Road, Yulee, FL, 32097, (hereinafter referred to as "Independent Contractor").

WHEREAS, the parties entered into an Agreement dated November 20, 2009, for Custodial Services for Yulee County Building; and

WHEREAS, the original agreement provided for an initial term of November 20, 2009 through November 19, 2010 and provided for one year renewals upon mutual agreement of the parties; and


WHEREAS, the parties agreed to extend the agreement for the subsequent periods beginning November 20, 2010 and ending November 19, 2015; and
