**TWELTH AMENDMENT TO PURCHASE, INSTALLATION AND  
MAINTENANCE SERVICE CONTRACT**

**Training, Maintenance and Warranty Service for the  
Nassau County E911 System**

**THIS AMENDMENT** made and entered into this 6th day of October, 2015 by and between the **Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida**, hereinafter referred to as the "County", and the **Kraus Associates Inc., DBA AK Associates** hereinafter referred to as the "Contractor", 326 Porta Rosa Circle, St. Augustine, FL 32092, as the Amendment for training, maintenance, warranty and support for the E911 System and associated programs and applications.

**WHEREAS**, the parties entered into the original contract on the 20<sup>th</sup> day of January, 2009 for the initial five (5) year term beginning January 20, 2009 and ending January 19, 2014; and

**WHEREAS**, the equipment installation has been completed and is operational, and the maintenance and warranty period has begun; and

**WHEREAS**, the contract allows the agreement to automatically renew and continue in force on a year-to-year basis until terminated by either party; and

**WHEREAS,** the parties entered into subsequent renewal periods beginning January 20, 2014 through January 19, 2016; and

**WHEREAS,** on 9/9/14 the parties entered into a subsequent agreement to upgrade the Solacom Selective Router and install Guardian call taking equipment that replaced the Plant CML 911 equipment. The upgrade was completed and placed into service on 3/17/15; and

**WHEREAS,** the State of Florida E911 Board approved the Spring 2015 Rural County Grant Program Application request, E911 Rural County Grant No. 15-04-18 in the amount of \$36,460.00 for E911 Maintenance.

**NOW, THEREFORE,** for and in consideration of the promises and mutual covenants and understanding contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend this agreement as follows:

1. SECTION II, 2. Costs, A. AK Elite Premier Maintenance and Extended Warranty Payment Schedule as follows:

**Support for MapSAG**

- MapSAG GIS Data Maint. Sys \$ 1,960.00
- 10/1/15 - 9/30/16

**DataMaster ALI DBMS Support**

- 6/1/15 - 5/31/16 \$ 6,500.00

**TOTAL**

**\$ 8,460.00**

Note: AK Elite Premier Maintenance for the period May 1, 2015 thru April 30, 2016 in the amount of \$28,000.00 is covered under separate agreement with AK Associates, Contract No. CM2158 dated 09/08/14.

2. SECTION III, 2. Term of Agreement: The "Initial Term" of this agreement terminated on January 19, 2014. Amendment No. 10 and 11 extended the agreement for the period beginning January 20, 2014 and ending January 19, 2016. This Agreement shall automatically renew for a one (1) year period beginning January 20, 2016 and ending January 19, 2017.


3. All other provisions of the original contract shall remain the same and in full force and effect.
