

AMENDMENT NO. 2 / FIRST EXTENSION TO THE
CONTRACT FOR DISASTER RECOVERY/DEBRIS MANAGEMENT FOR
NASSAU COUNTY, FLORIDA

THIS ADDENDUM entered into this 12th day of October, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **ASHBRITT, INC.**, 480 South Andrews Avenue, Suite 103, Pompano Beach, Florida 33069, (hereinafter referred to as "Contractor").

WHEREAS, the parties entered into an Agreement dated October 11, 2010 for Disaster Recovery/Debris Management for Nassau County, Florida; and

WHEREAS, the original agreement provided for an initial term of five (5) years beginning October 11, 2010 and ending October 10, 2015, with an option to extend upon mutual contract between both parties; any extension of performance period under this provision shall be in two (2) year increments.

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Article 4 of the Agreement for Disaster Recovery/Debris Management dated October 11, 2010, the performance period is hereby extended for an additional two (2) year term beginning October 11, 2015 and ending October 10, 2017.


