**AMENDMENT NUMBER 4/FOURTH EXTENSION TO THE  
CONTRACT FOR SAISS PROJECT SHOREBIRD MONITORING SURVEYS**

THIS AMENDMENT entered into this 18th day of November, 2015 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as “County”) and **SCHEDA ECOLOGICAL ASSOCIATES, INC.**, 5892 East Fowler Avenue, Tampa, Florida 33617, (hereinafter referred to as “Contractor”).

**WHEREAS**, the parties entered into an Agreement dated April 4, 2012; and

**WHEREAS**, the original agreement provided for an initial term beginning April 1, 2012 and ending March 31, 2013, with an option to extend for four (4) additional one (1) year periods upon written agreement of both parties; and

**WHEREAS**, the parties agreed to extend the agreement for three (3) annual periods beginning April 1, 2013 and ending March 31, 2016; and

**WHEREAS**, the parties desire to amend and extend said Agreement for the fourth and final one-year extension period; and

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 2 of the Contract for SAISS Project Shorebird Monitoring Surveys dated April 1, 2012, the performance period is hereby extended for an additional one (1) year beginning April 1, 2016 and ending March 31, 2017.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
