AMENDMENT NUMBER 4/EXTENSION TO THE CONTINUING CONTRACT FOR MISCELLANEOUS ENGINEERING SERVICES FOR NASSAU AMELIA UTILITY

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:
