

**AMENDMENT to Work Authorization for Debris Monitoring Services – Hurricane Matthew**

This Amendment to the Work Authorization (“Amendment”) is effective as of November 2, 2016 by and between the **Nassau County, Florida** (hereinafter referred to as Client) and **Witt O’Brien’s LLC** (hereinafter referred to as “Consultant”).

**WHEREAS**, the parties entered into a certain Agreement No. CM1997 for Disaster Debris Monitoring (hereinafter referred to as “Agreement”) on August 21, 2013 which has been amended to reflect an extension to the term of the Agreement for one year beginning August 22, 2016 and ending August 21, 2017; and

**WHEREAS**, the parties desire to amend the Work Authorization pursuant to 44 CFR 13.36; and


**WHEREAS** , Client issued a Notice to Proceed on October 6, 2016 for mobilization of equipment, personnel and supplies to assist with debris removal as a result of Hurricane Matthew.

**NOW, THEREFORE**, in consideration of the premises and other good and valuable consideration, the parties agree to amend the Work Authorization as follows:

1. Not to Exceed Amount. The Not to Exceed Amount under this agreement shall be increased from Two-Hundred Thousand Dollars (\$200,000.00) to Four-Hundred Thousand Dollars (\$400,000.00) to cover the current expenses and the remaining scope of work under the contract.
2. All other terms and conditions of the Agreement, as amended, shall remain in full force and effect.
