MODIFICATION OF CONTRACT

THIS MODIFICATION OF CONTRACT is made and entered into this 15th day of August, 2017, by and between BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as ("County") and Herc Rentals, Inc. , whose principal address is 27500 Riverview Center Blvd, Bonita Springs, FL 34134, hereinafter referred to as ("HERC RENTALS, INC.").

WITNESSETH:

WHEREAS, the County entered into a contract (No. CM2250) with Hertz Equipment Rental Corporation, dated September 28, 2015; and

WHEREAS, the County has been notified that Herc Rentals, Inc., has become successor to Hertz Equipment Rental Corporation as of June 10, 2016. and


WHEREAS, Herc Rentals, Inc. agrees to the terms of Contract No. CM2250, as amended by Contract No. CM2250-A1.

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

2. All terms and conditions of contract (CM2250) shall remain in full force and effect.




