

AMENDMENT NO. 2 / SECOND EXTENSION TO THE
AGREEMENT FOR LIQUID SODIUM HYPOCHLORITE

THIS ADDENDUM entered into this 26th day of September, 2016 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Allied Universal Corporation**, 3901 NW 115 Avenue, Miami, FL 33178, (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated August 21, 2013 for Liquid Sodium Hypochlorite; and


WHEREAS, the original agreement provided for an initial term of two (2) years beginning October 1, 2013 and ending September 30, 2015, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and


WHEREAS, the parties agreed to extend the agreement for the period beginning October 1, 2015 and ending September 30, 2016; and

WHEREAS, the parties desire to amend and extend said Agreement.


NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 20 of the Agreement for Liquid Sodium Hypochlorite dated August 21, 2013, the performance period is hereby extended for an additional one (1) year beginning October 1, 2016 and ending September 30, 2017.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
3. Time is of the essence.



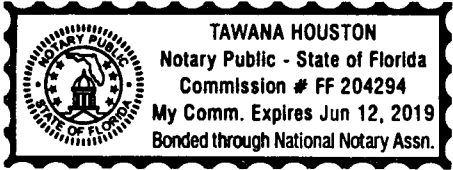
