AMENDMENT NO. 1 / FIRST EXTENSION TO THE BROKER/AGENT AGREEMENT

THIS ADDENDUM entered into this 25**t**h day September , 2017 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and MFB Financial, Inc., dba The Bailey Group, whose principal office is located at 1200 Plantation Island 210, Saint Drive. Suite Augustine, Florida 32080, (hereinafter referred to as "Broker/Agent").

WHEREAS, the parties entered into an Agreement dated July 5, 2016 for a Broker/Agent to service the County's employee insurance programs; and

WHEREAS, the original agreement provided for an initial term of one (1) year beginning July 6, 2016 and ending September 30, 2017 with the option for a possible modification of the anniversary/renewal date through December 30, 2017 to coincide with the County's insurance benefit programs. In addition to the modification of the anniversary/renewal date, the agreement provides for a renewal option to extend for a period of one (1) year increments for up to three (3) additional consecutive one (1) year terms; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Article V of the Broker/Agent Agreement dated July 6, 2016, the anniversary/renewal date shall be modified, to coincide with the County's insurance benefit programs, by extending the agreement through December 31, 2017.
- 2. In accordance with Article V of the Broker/Agent Agreement dated July 6, 2016, the agreement shall renew, with no cost increase, for a one (1) year term, from the modified Anniversary/renewal date, beginning January 1, 2018 and ending December 31, 2018.
- 3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
