AMENDMENT NO. 3 / SECOND EXTENSION TO THE AGREEMENT FOR READY MIX CONCRETE

THIS ADDENDUM entered into this 26th day of September, 2016 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida, (hereinafter referred to as "County") and ARGOS READY MIX LLC, 3015 Windward Plaza, Suite 300, Alpharetta, GA 30005, (hereinafter referred to as "Vendor").

WHEREAS, an Assignment/Approval of Assignment Agreement was executed effective March 8, 2014 which assigned the agreement from Vulcan Materials Company to Argos Ready Mix LLC; and

WHEREAS, the original agreement provided for an initial term of two (2) years beginning October 1, 2013 and ending September 30, 2015, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the parties agreed to extend the agreement for the period beginning October 1, 2015 and ending September 30, 2016; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 20 of the Agreement for Ready Mix Concrete dated August 12, 2013, the performance period is hereby extended for an additional one (1) year beginning October 1, 2016 and ending September 30, 2017.
- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
