AMENDMENT NO. 3 / SECOND EXTENSION TO THE AGREEMENT FOR TOTAL LEACHATE MANAGEMENT

WHEREAS, the parties agreed to extend the agreement for the period beginning October 1, 2015 and ending September 30, 2016; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 20 of the Agreement for Total Leachate Management dated June 19, 2013, the performance period is hereby extended for an additional one (1) year beginning October 1, 2016 and ending September 30, 2017.
- 2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
- 3. Time is of the essence.
