CHANGE ORDER

INSTRUCTIONS

A. GENERAL INFORMATION

This document was developed to provide a uniform format for handling contract changes that affect Contract Price or Contract Times. Changes that have been initiated by a Work Change Directive must be incorporated into a subsequent Change Order if they affect Contract Price or Times.

Changes that affect Contract Price or Contract Times should be promptly covered by a Change Order. The practice of accumulating change order items to reduce the administrative burden may lead to unnecessary disputes.

If Milestones have been listed, any effect of a Change Order, thereon, should be addressed.

For supplemental instructions and minor changes not involving a change in the Contract Price or Contract Times, a Field Order may be used.

B. COMPLETING THE CHANGE ORDER FORM

Engineer / Architect / Etc. initiates the form, including a description of the changes involved and attachments based upon documents and proposals submitted by Contractor, or requests from the County or both.

Once Engineer / Architect / Etc. has completed and signed the form, all copies should be sent to Contractor for approval. After approval by Contractor, all copies should be sent to the County for approval. Engineer should make distribution of executed copies after approval by the County.

If a change only applies to Contract Price or to Contract Times, cross out the part of the tabulation that does not apply.

We have just received word back from the motor manufacturer on their delivery schedule. The earliest we can have the motor on site is Thursday December 22. Omar,

We have spoken with the blower manufacturer and they have agreed to address the vibration noise. They are telling us that for a motor this size, 25hp, it will be most efficient to replace the motor rather than inspecting and servicing it. This motor is explosion proof TEFC per the county specifications. It is not a stock motor and has a minimum 4 week lead time, however if a standard TEFC motor would be acceptable, these are readily available. Please let us know how you would like to proceed so we can get a motor on order and we can begin working on a contract finish date extension if necessary.
