**AMENDMENT NO. 01 / FIRST EXTENSION TO THE**  
**AGREEMENT FOR EQUIPMENT RENTAL SERVICES**

THIS ADDENDUM entered into this 12 day of December, 2017 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Bobcat of Jacksonville** located at 11657 Philips Highway, Jacksonville, Fl. 32256 (hereinafter referred to as "Contractor").

**WHEREAS**, the parties entered into an Agreement dated September 28, 2015; and

**WHEREAS**, the original agreement provided for an initial term of two (2) years beginning October 1, 2015 and ending September 30, 2017, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments.

**WHEREAS**, the parties desire to amend and extend said Agreement.

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. In accordance with Section 20 of the Agreement for Equipment Rental Services dated September 30, 2015, the performance period is hereby extended for an additional one (1) year beginning October 1, 2017 and ending September 30, 2018.
2. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
