

**AMENDMENT NO. 1 / FIRST EXTENSION TO THE
AGREEMENT FOR PUBLIC RELATIONS FOR THE AMELIA ISLAND
AND TOURIST DEVELOPMENT COUNCIL**

THIS ADDENDUM entered into this 20th day of September, 2017 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **Hayworth Creative, at 700 W. Granada Boulevard, Suite 100, Ormond Beach, Florida 32174**, (hereinafter referred to as "Consultant").

WHEREAS, the parties entered into an Agreement dated September 24, 2012; and


WHEREAS, the original agreement provided for an initial term of five (5) years beginning October 1, 2012 and ending September 30, 2017, with an option to extend upon recommendation by the AITDC and the AITDC's recommendation to the County and the County's subsequent approval; any extension of performance period under this provision shall be in one (1) year increments.

WHEREAS, the parties desire to extend said Agreement and to amend section 3.6 Availability of Funds to redact the verbiage "The County hereby covenants to budget and appropriate from legally available funds."

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 3.5 of the Agreement for public relations for the Amelia Island and Tourist Development council dated September 24, 2012, the performance period is hereby extended for an additional one (1) year beginning October 1, 2017 and ending September 30, 2018.
2. Section 3.6 Availability of Funds has been amended to redact the verbiage "The County hereby covenants to budget and appropriate from legally available funds."
3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
