**AMENDMENT NUMBER 4/FOURTH EXTENSION TO THE SERVICE
AGREEMENT FOR EMPLOYEE BACKGROUND SCREENINGS**

THIS AGREEMENT entered into this 13th day of June, 2018 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **PREMIER SCREENINGS AND LABOR SERVICES, INC.** located at 5575 S. Semoran Blvd., Suite 6, Orlando, FL 32822; (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an agreement on June 15, 2014 for the provision of Employee Background Screenings; and
