FIRST AMENDMENT TO THE AGREEMENT FOR A NASSAU COUNTY FIRE RESCUE RESERVE/SUPPORT VOLUNTEER FIRE UNIT

THIS AGREEMENT made and entered into this all day of Movember, 2017 by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, a political subdivision of the State of Florida, hereinafter referred to as the "Board", and the YULEE VOLUNTEER FIRE DEPARTMENT, 86048 Goodbread Road, Yulee, Florida 32097, hereinafter referred to as "YVFD".

WHEREAS, the Board and YVFD entered into an agreement on June 30, 2017 to provide service as a Nassau County Fire Rescue Reserve/Support Volunteer Fire Unit; and

WHEREAS, it has become necessary to amend the agreement entered into on June 30, 2017, specifically Article 11, regarding the effective date of the agreement and auto renewal provisions; and

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

1. Article 11 shall be amended as follows: "This Agreement shall be effective for the period beginning May 31, 2017 and ending May 31, 2018.
