FUNDING AGREEMENT FOR FISCAL YEAR 2017-2018 FOR NASSAU COUNTY SOIL AND WATER CONSERVATION DISTRICT

This agreement entered into this A day of Myembe(, 2017, by and between the BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY", and NASSAU COUNTY SOIL AND WATER CONSERVATION DISTRICT, P.O. Box 753, Callahan, Florida 32011, hereinafter referred to as the "DISTRICT".

WHEREAS, annually the Board of County Commissioners of Nassau County, covenants to budget and appropriate budget funds for the operation of the Nassau County Soil and Water Conservation District.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. For the sum of \$28,325.00, which shall be paid in quarterly installments during the months of December, February, May and August, the DISTRICT does hereby agree to perform services that will benefit the residents of Nassau County. Said services to include but not be limited to the following:
- a. Continuing the present level of services provided for the residents of Nassau County.
- 2. The District shall submit simultaneously to the County Manager and the Clerk an annual accounting acceptable to the Clerk on or before May 1st of each fiscal year in which the District received funding from the County. Additionally, the District shall make its books available for inspection by a designee of the County upon reasonable notice. Failure of the District to provide the

annual accounting record by the time specified shall result in the revocation of granting of further funds and reimbursement of funds distributed during the year for which no report was submitted.

- 3. All facilities, programs, and services should be compliant with the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA). Failure to provide facilities, programs, and services that are compliant with both the Florida Accessibility Code and the federal Americans with Disabilities Act (ADA) shall be considered a breach of contract.
- 4. The term of this agreement shall commence October 1, 2017 and terminate September 30, 2018.
- 5. This Agreement shall be amended in writing from time to time by mutual consent of parties.
