

**AMENDMENT NO. 2 TO THE
AGREEMENT FOR UNIFORM SHIRT RENTAL**

THIS ADDENDUM entered into this 29th day of July, 2019 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and Unifirst Corporation, located at 1446 Haines Street, Jacksonville, Fl. 32206 (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an Agreement dated November 13, 2017 for uniform shirt rental services; and

WHEREAS, the technical specifications/scope of work in the original agreement allows for these services to be offered to other departments within the County; and

WHEREAS, on March 14, 2018, the Solid Waste Department added the uniform rental and mat services; and

WHEREAS, the Solid Waste Department desires to add an additional garment to the uniform rental services provided under this agreement; and

WHEREAS, the parties desire to amend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. Vendor shall provide customer service to the Solid Waste Department for the rental and service of the uniform shirt as follows:
