**AMENDMENT NO. 2/SECOND EXTENSION TO THE
CONTRACT FOR FILL MATERIALS - A-3 AND A-2-4 & CLAY**

THIS AMENDMENT entered into this 19th day of September, 2019 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **TIM PREP, INC.**, 18500 MacClenny Road, Jacksonville, Florida 32234 (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Fill Materials - A-3 and A-2-4 & Clay* (hereinafter referred to as "Contract") on or about August 17, 2016;

WHEREAS, the original *Contract* provided for an initial term beginning August 17, 2016 and ending August 16, 2018, with an option to extend upon mutual contract between the Vendor and the County; and shall allow for one (1) year extensions, not to exceed four (4) years in length; and


WHEREAS, the parties agreed to extend the *Contract* on October 8, 2018 for a period of one (1) year beginning August 17, 2018 and terminating on August 16, 2019; and

WHEREAS, the parties desire to extend the *Contract* for an additional one (1) year term.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 20 of the *Contract*, the performance period is hereby extended for an additional one (1) year beginning August 17, 2019 and ending August 16, 2020.
2. All other provisions of said *Contract* not in conflict with this Amendment shall remain in full force and effect.
