**AMENDMENT NO. 01/FIRST EXTENSION TO THE
CONTRACT FOR TOTAL AQUATIC POND AND DITCH MANAGEMENT**

THIS AMENDMENT entered into this 19th day of September, 2019 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **DeAngelo Brothers, LLC., d/b/a Aquagenix**, located at 6209 Bowdendale Avenue, Jacksonville, Florida hereinafter referred to as "Vendor").

WHEREAS, the parties entered into a *Contract for Total Aquatic Pond and Ditch Management* (hereinafter referred to as "Contract") on or about August 8, 2016; and


WHEREAS, the original *Contract* provided for an initial term beginning October 1, 2016 and terminating September 30, 2019, with an option to extend for two (2) additional terms in one (1) year increments upon mutual contract between the Vendor and the County; total contract length and individual one (1) year extensions shall not exceed five (5) years from date of execution.

WHEREAS, the parties desire to extend the *Contact*.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 18 of the Contract, the performance period is hereby extended for an additional one (1) year beginning October 1, 2019 and terminating September 30, 2020.
2. All other provisions of the Contract not in conflict with this Amendment shall remain in full force and effect.
