**AMENDMENT NO. 02 / SECOND EXTENSION TO THE
AGREEMENT FOR EQUIPMENT RENTAL SERVICES**

THIS ADDENDUM entered into this 24th day of October, 2018 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, a political subdivision of the State of Florida**, (hereinafter referred to as "County") and **Bobcat of Jacksonville** located at 11657 Philips Highway, Jacksonville, Fl. 32256 (hereinafter referred to as "Contractor").

WHEREAS, the parties entered into an Agreement dated September 28, 2015; and

WHEREAS, the original agreement provided for an initial term of two (2) years beginning October 1, 2015 and ending September 30, 2017, with an option to extend upon mutual contract between the vendor and the County; any extension of performance period under this provision shall be in one (1) year increments; and

WHEREAS, the original agreement was renewed for one (1) year beginning October 1, 2017 and ending September 30, 2018; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:


1. In accordance with Section 20 of the Agreement for Equipment Rental Services dated September 30, 2015, the performance period is hereby extended for an additional one (1) year beginning October 1, 2018 and ending September 30, 2019.
