MAINTENANCE AGREEMENT

THIS MAINTENANCE AGREEMENT is made this day of ______ 2018, by NASSAU COUNTY, FLORIDA, a political subdivision, a body corporate existing under the laws of the State of Florida, whose post office address is 96135 Nassau Place, Yulee, FL 32207 (hereinafter referred to as the "<u>County</u>") and AMELIA BLUFF, LLC, a Florida limited liability company whose post office address is 4339 Roosevelt Blvd., Suite 400, Jacksonville, FL 32210 (hereinafter referred to as "<u>Owner</u>").

BACKGROUND FACTS. Owner is the owner of the real property in Nassau County, Florida, described in <u>Exhibit A</u> attached (the "<u>Owner Parcel</u>"). Owner intends to install pipes and mains for sewer collection to serve the Owner Parcel ("<u>Private Facilities</u>") within the right of way of Citrona Drive, a public right of way in Nassau County, Florida. As part of such installation, the County requires that Owner assume responsibility for the maintenance of the Private Facilities. Therefore, for good and valuable consideration, the parties agree that:

1. **OBLIGATIONS OF OWNER**. Owner shall cause the plans and specifications for installation and repair of the Private Facilities to be reviewed and approved by the County. Owner represents and warrants that all improvements in the Private Facilities shall be constructed, designed, and installed in accordance with County requirements. Owner, its successors and assigns, shall at its own cost, and at no cost to the County, assume all responsibility and liability for the installation, operation, maintenance, design, repair and replacement of the Private Facilities. Owner shall be liable to the County for all costs, fines, charges, fees, and expenses associated with, arising out of or related to any cleanup of effluent discharged from leaks or damaged Private Facilities and Owner shall be liable to the County for any and all reasonable repairs made by the County to the Private Facilities.

2. <u>RUNNING OF BENEFITS AND BURDENS</u>. All provisions of this instrument, including the benefits and burdens, run with the land and are binding upon and inure to the heirs, successors and assigns of the parties hereto. Owner's obligations contained in this instrument may be assigned to and assumed by a homeowners association governing the Owner Parcel.

3. <u>CONSTRUCTION</u>. The rule of strict construction does not apply to this grant. This grant shall be given a reasonable construction so that the intention of the parties to confer a commercially usable right of enjoyment on the Owner is carried out.
